Organizations are assigned a Registration Category upon registration with the NY Charities Bureau:

**7A** filers are registered to solicit contributions in New York under Article 7-A of the Executive Law ("7A")

**EPTL** filers are registered under the Estates, Powers & Trusts Law ("EPTL") because they hold assets and/or conduct activities for charitable purposes in NY.

**DUAL** filers are registered under both 7A and EPTL.

**EXEMPT** filers have registered with the NY Charities Bureau and meet conditions in **Schedule E - Registration Exemption for Charitable Organizations**. These organizations are not required to file annual financial reports but may do so voluntarily.

IT SUPPORTS THE ANNUAL REMEMBRANCE ACTIVITIES ON THE ANNIVERSARY OF THE FIRE EACH MARCH 25, AND ENCOURAGES ACTIVISM BY AND FOR WORKERS AROUND THE WORLD. TO THAT END, THE REMEMBER THE TRIANGLE FIRE COALITION IS CURRENTLY WORKING TO ESTABLISH A PERMANENT ART MEMORIAL TO THOSE WHO DIED IN THE FIRE, SO THAT THEIR SACRIFICE WILL NEVER BE FORGOTTEN.

## THE FIRE

THE TRIANGLE SHIRTWAIST COMPANY WAS LOCATED ONE BLOCK EAST OF WASHINGTON SQUARE PARK. THERE WERE OVER 500 EMPLOYEES - MOST WERE YOUNG WOMEN, MOST WERE RECENT IMMIGRANTS. ON MARCH 25, 1911, A FIRE BROKE OUT ON THE 8TH FLOOR. WORKERS RAN TO THE FIRE ESCAPE. IT COLLAPSED, DROPPING THEM TO THEIR DEATHS. ON THE 9TH FLOOR A CRITICAL EXIT WAS LOCKED. PEOPLE ON THE STREET WATCHED AS THE WORKERS BEGAN TO JUMP OUT THE WINDOWS. FIRE TRUCKS ARRIVED BUT THEIR LADDERS ONLY REACHED THE 6TH FLOOR. THE ELEVATORS RAN AS LONG AS THEY COULD AS WORKERS PRESSED INTO THE CARS; SOME TUMBLED DOWN THE ELEVATOR SHAFT.

IN THE END 146 PEOPLE DIED. THERE WAS A TRIAL BUT THE OWNERS, LONG KNOWN FOR THEIR ANTI-UNION ACTIVITIES, GOT OFF. THE FIRE BECAME A RALLYING CRY FOR THE INTERNATIONAL LABOR MOVEMENT. MANY OF OUR FIRE SAFETY LAWS WERE CREATED IN RESPONSE TO THIS TRAGIC EVENT.
